## **RULES:**

1. Entry fee \$25.00 (check or money order). Checks made out to Dana Axelson (cash or check at the field)
2. Competitors must enter & compete in all events to be eligible for Athlete of the Day
3. Must be 18 years old or over
4. Must be registered and on the field before the first event begin.
5. Must sign waiver (below)
6. Should endeavor to wear a kilt & hose with athletic shorts underneath. Some kilts will be available for rental on the day of the games for \$10.00
7. Judge's decision is final in all events. The judge can disqualify a competitor if he feels the athlete poses a danger to himself or anyone else or poor sportsmanship.
8. Competitors must be a current member of a recognized Scottish Athletic group (RMSA, SAAA, SSAA or NASGA) to compete. Forms for RMSA (the regional group) will be available on the field or the website ([www.rmsa.org](http://www.rmsa.org) \$20/year).
